EVEREST PARK

The parking is limited at the ballpark and visiting team fans are encouraged to utilize 'car pools' from their hotels to Everest Park. The park is in compliance with the American Disabilities Act as to access.

OVERALL INFORMATION

We will be providing all teams with uniforms, housing, meals (either a food allowance to the Manager or meals directly, see **MEALS** Section below) and transportation while they are at the World Series. If a team does not accept our housing, they are on their own as to expenses for housing, transportation and food. Friends and family members of the team are on their own as to all arrangements. We are only providing transportation and housing for up to 14 players, the manager and up to 2 coaches listed on your Eligibility Affidavit.

TRAVEL

All teams will be arriving at the Seattle SeaTac airport. A Tournament Team Host/Uncle/Aunt will meet each team at the airport. With the new Airport Security requirements we cannot meet you at the gate so the Host/Uncle/Aunt will meet you at the Luggage/Baggage area for your flight. When you get off the plane, follow the Airport signs to the Baggage Claim area for your Airline/Flight Number and the Host/Uncle/Aunt will meet you there. The host will assist the team in getting their luggage/equipment and then will transport the team to the ballpark. Teams coming in a day early will be escorted directly to their hotel and they will come to the ballpark Saturday morning to get their uniforms. **Make sure the Regional Director has sent us a digital picture of your team in case we need it for the program (.jpg format preferred).**

NECESSARY TEAM INFORMATION

Roster

Fax or email a **TYPED or PRINTED** copy of your roster (the pronunciation form attached preferred) and a contact name and phone number (in case we have questions before you arrive) **no later than 9:00 PM (PST) on August 10th**. This **typed or printed** copy of your roster shall be with all names written as the players, manager and coaches would like to have them appear on the Participation Certificate. Also fax a **typed or printed** copy of the Housing List **no later than 9:00 PM (PST) on August 10th** showing which players will be rooming together. Please use the attached HOUSING FORM.

Interpreter

Inform us if you will need an interpreter for your team. The teams coming in from outside the USA must let us know if they have members and staff that speak English or if they do not have English speaking members, we will have to provide interpreters for that team.

Model Release

Get the "Model Release" Form from your Regional Tournament Director (a copy is at the end of this packet) and have each of your players' parents complete a form and return it to you. You are to have these completed before you get to the World Series and turn them into the World Series Tournament Director upon arrival at the World Series site.

Medical Release

Each team Manager **MUST** have the required medical release form for each player with him or her. We have checked with our local hospital and they will accept the Little League Medical Release form for treatment. They will still try to contact the parents but they will not delay treatment for this. If you are using some other form, please make sure that it has all the information required by the Little League form on it. It will also be better for the hospital if each form is notarized, although this is not mandatory.

Little League Headquarters has requested that in addition to the eligibility information, medical release forms and affidavit, it is highly recommended that World Series teams bring current immunization records with them for each manager, coach and player in case our medical staff or local hospital needs them. Please get with your parents to get this information.

Concussion Information

Read the attached Junior Softball World Series excerpt on Concussions in our SAFETY PLAN and FILL OUT & SIGN THE MANAGERS, COACHES and PLAYERS CONCUSSION FORMS and have them ready to turn into the Tournament Director upon arrival at Kirkland. These forms are required to be completed by Washington State Law.

MEALS

Breakfast will be provided for all umpires, players, managers and coaches at the hotel each morning between 7:30 AM and 9:00 AM. A given amount of money will be provided to the Managers and Umpires for Lunches and Dinners. They may use this

money as they want for feeding their teams. It should be clearly pointed out that this money **MAY NOT** be enough for feeding your team so each team should be prepared to supplement the money as required.

HOUSING

Fill out your Team Pairing for Housing Purposes sheet for the housing chairperson (form attached). This form should be immediately emailed or faxed to the Tournament Director.

An attached local hotel/motel list is provided for families in locating where to stay. All Teams and the Umpires will be staying at Baymont Inn & Suites in Kirkland. Details for team housing are contained later in this information. This is a busy "Hotel/Motel" season in the Seattle/Kirkland area so it is important that families make their reservations as early as possible.

TRANSPORTATION

Each team will be met at the baggage claim area by a representative of the Tournament Committee. We will be providing each team with three vehicles for the TEAMS use while at the World Series. The Tournament Committee Member that meets you will be assisting in getting you the vehicles.

Primary Vehicle Plan - We will provide you with up to three vehicles (depending on the number of players and adults on your affidavit) from a local auto dealer. In this option, the Committee Member will meet you at the baggage claims area, transport you to the field, have you fill out some paper, get a copy of your drivers license, and issue you the vehicles for your team. These will be "**Loaner Vehicles, Not Rentals**". As a condition of getting to use these vehicles, each Manager and Coach will provide to the Team Host a **Valid (in the USA) Drivers License** and they will also fill out and sign a **DRIVERS RELEASE FORM** for use of the vans. This Drivers Release Form requires that the signer will be responsible for a certain amount of "**deductible**" (up to \$1,000) if any damage is done to the Loaner Vans. Please have all three Manager/Coaches read this form and be ready to provide a valid Driver's license so we can make a copy of it for Williamsport's use. **If you have an accident, you will be REQUIRED to provide the "deductible" amount to the Tournament Committee BEFORE you leave the World Series.** After repairs are made, we will refund any amount of the "deductible" not needed for the repairs.

IF WE DO NOT HAVE ENOUGH VEHICLES FROM A DEALERSHIP, WE WILL MAKE DEALERSHIP VEHICLES AVAILABLE TO TEAMS THAT WE CHOOSE (OUR CHOICE, NOT THE TEAMS CHOICE) AND WE WILL ASK THE REMAINING TEAMS TO OBTAIN RENTAL VEHICLES - We will provide you with up to three vehicles (depending on the number of players and adults on your affidavit) from Enterprise Rental agency. In this option, the Committee Member will meet you at the baggage claim area, escort you to the Enterprise Rent a Car agency and assist you in getting three vehicles that will be pre-reserved for your team. You will provide a drivers license, credit card and reservation number (reservation number will be (REGIONAL

NAME) - World Series" for the rental of these three vehicles. The World Series will pay you for the pre-arranged base cost of this rental but the billing by the car rental agency will be to you on your credit card. Any additional "options" you take on the rental, such as insurance and returning the vehicle with the gas tank NOT FULL or damages, will be at your expense. The Committee member will stay with you during the rental process and will lead you back to the airport to pick up your team and then lead you to the field.

ADDITIONAL EVENTS

Dinner will be provided by the Tournament Committee on Tuesday at "Teen Night," an event presented by the Tournament and Host Team, at the Kirkland Teen Center for all the teams. Dinner will be provided. Your Uncle/Host should provide directions. On Thursday, there will be an Awards Banquet at the Lake Washington Technical College. **As part of the banquet on Thursday night, we invite each team to take part in the activities. Some of the teams provide skits or native dances and some of the talented individuals on the teams entertain with singing or dancing. If anyone on your team wants to participate, or if your team wants to put on some entertainment, please contact either John Chadwick or Debbie Lee after you arrive and before Wednesday of the week.**

They are caused by a bump, blow, or jolt to the head, or by a blow to another part of the body with the force transmitted to the head. They can range from mild to severe and can disrupt the way the brain normally works. Even though most concussions are mild, all concussions are potentially serious and may result in complications including prolonged brain damage and death if not recognized and managed properly. In other words, even a "ding" or a bump on the head can be serious. You can't see a concussion and most sports concussions occur without loss of consciousness. Signs and symptoms of concussion may show up right after the injury or can take hours or days to fully appear. If any player reports any symptoms of concussion, or if you notice the symptoms or signs of concussion yourself, seek medical attention right away.

Symptoms may include one or more of the following:

Prevention and Preparation

As a coach, you can play a key role in preventing concussions and responding to them properly when they occur. Here are some steps you can take to ensure the best outcome for your athletes and the team:

- **Educate athletes and parents about concussions.** Talk with athletes and their parents about the dangers and potential long term consequences of concussions. Explain your concerns about concussions and your expectations of safe play to athletes, parents and coaches. Pass out the concussions fact sheets for athletes and for parents at the beginning of the season and again if a concussion occurs.
- **Insist that safety comes first.**
 - Teach athletes safe playing techniques and encourage them to follow the rules of play.
 - Encourage athletes to practice good sportsmanship at all times.
 - Make sure athletes wear the right protective equipment for their activity. Protective equipment should fit properly, be well maintained and be worn consistently and correctly.
 - Review the athlete fact sheet with your team to help them recognize the signs and symptoms of a concussion.

ACTION PLAN

What should a coach do when a concussion is suspected

Any athlete even suspected of suffering a concussion should be removed from the game or practice immediately. No athlete may return to activity after an apparent head injury or concussion, regardless of how mild it seems or how quickly symptoms clear, without medical clearance. Close observation of the athlete should continue for several hours. The new "Zackery Lystedt Law" in Washington now requires the consistent and uniform implementation of long and well-established return to play concussion guidelines that have been recommended for several years:

"a youth athlete who is suspected of sustaining a concussion or head injury in a practice or game shall be removed from competition at that time"

and

"...may not return to play until the athlete is evaluated by a licensed health care provider trained in the evaluation and management of concussion and received written clearance to return to play from that health care provider". You should also inform your player's parents if you think that a player may have a concussion. Remember, it's better to miss one game than miss the whole season. And when in doubt, the athlete sits out.

What can happen if a player keeps on playing with a concussion or returns to soon?

Athletes with the signs and symptoms of concussion should be removed from play immediately. Continuing to play with the signs and symptoms of a concussion leaves the young athlete especially vulnerable to greater injury. There is an increased risk of significant damage from a concussion for a period of time after that concussion occurs, particularly if the athlete suffers another concussion before completely recovering from the first one. This can lead to prolonged recovery, or even to severe brain swelling (second impact syndrome) with devastating and even fatal consequences. It is well known that adolescent or teenage athlete will often under report symptoms of injuries. And concussions are no different. As a result, education of

administrators, coaches, parents and students is the key for student-athlete's safety.
