RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, INDEMNITY
AND RIGHTS AGREEMENT
("Release")

IN CONSIDERATION of being permitted to participate in the activities at either the Little League Softball World Series (LLSWS) or Little League Baseball World Series (LLBWS), I, on behalf of myself and on behalf of my minor child(ren) or legally incapacitated adult named below (minor child(ren)/ward(s)), agree to the following on behalf of myself, my personal representatives, heirs, executors, administrators, assigns, next of kin, and on behalf of my minor child(ren)/ward(s), his/her personal representatives, heirs, executors, administrators, assigns, and next of kin:

To the fullest extent permitted by law, I, and on behalf of my minor child(ren)/ward(s), hereby agree to release, discharge, indemnify, defend, hold harmless, and covenant not to sue, Little League Baseball, Incorporated (“LLB”), Little League Flagship Store, The World of Little League Museum, ADIDAS AMERICA, INC., Zurich Cover-More Global Travel, Inc., Church & Dwight Co., Inc., Easton Diamond Sports, LLC, Rawlings Sporting Goods Company, Inc., Edgewell Personal Care Brands, LLC., ESPN, Inc., FanThreeSixty, DICK’S Sporting Goods Inc., GivBee, LLC, The J.M. Smucker Company, Motive Group, Inc., Major League Baseball Charities, Inc., Major League Baseball Youth Foundation, National Cattlemen’s Beef Association, New Era Cap, LLC, New York Life Insurance Company, NS Brands, LTD, Pitt-Greenville Convention & Visitors Authority, S.C Johnson & Son, Inc., T-Mobile USA, Inc., The Topps Company, Inc., and the MLB Entities (defined below) and any other sponsors (collectively, the “Sponsors”), together with the Sponsors’ respective parent companies, affiliates, subsidiaries, officers, directors, shareholders, employees, agents, successors and assigns (hereinafter collectively "Released Parties") FOR ANY AND ALL CLAIMS, LIABILITIES, SUITS, DEMANDS, COSTS, EXPENSES AND ACTIONS OF ANY KIND WHATSOEVER WHICH MAY ARISE FROM OR IN CONNECTION WITH MY, OR MY MINOR CHILD(REN)/WARD(S)’ PRESENCE AT OR PARTICIPATION IN THE ACTIVITIES AT THE LLSWS OR LLBWS INCLUDING, WITHOUT LIMITATION, ANY PROPERTY DAMAGE, PERSONAL INJURIES, ILLNESS, DISABILITY, DEATH OR OTHER DAMAGE, TRANSMISSION OF PERSONAL INFORMATION, COMPROMISED PRIVACY AND SECURITY OF PERSONAL INFORMATION, OR THE CIRCUMVENTION OF ANY PRIVACY SETTINGS OR SECURITY MEASURES SUFFERED BY ME, MY MINOR CHILD(REN)/WARD(S), THE RELEASED PARTIES, OR ANY THIRD PARTY RELATED TO SPORTS ACTIVITIES OR OTHER GAMES THAT I OR MY MINOR CHILD(REN)/WARD(S) MAY PARTICIPATE IN CAUSED, IN WHOLE OR IN PART, BY

THE ORDINARY NEGLIGENCE OF THE RELEASED PARTIES,. As used herein, the “MLB Entities” shall mean MLB Advanced Media, L.P., the Office of the Commissioner of Baseball (“BOC”), its Bureaus, Committees, Subcommittees and Councils, the Major League Baseball Clubs (“Clubs”), Major League Baseball Properties, Inc., Tickets.com, LLC, The MLB Network, LLC, each of their parent, subsidiary, affiliated and related entities, any entity which, now or in the future, controls, is controlled by, or is under common control with the Clubs or the BOC and the owners, general and limited partners, shareholders, directors, officers, employees and agents of the foregoing entities.

I represent and warrant that I am at least eighteen (18) and the age of majority in my state of residence and in the Commonwealth of Pennsylvania and agree to this Release on behalf of myself and my minor child(ren)/ward(s). I assume full responsibility for my presence at and participation in the events and activities at the LLSWS or LLBWS. This includes any rules or guidelines which may be provided by the Released Parties or anyone acting on behalf of the Released Parties. I understand and acknowledge that this Release does not grant me or my minor child(ren)/ward(s) any right to be present at or participate in the LLSWS or LLBWS or other activities at the LLSWS or LLBWS, and that the Released Parties may require me or my minor child(ren)/ward(s) to leave the LLSWS or LLBWS or cease participation in any or all activities at any time for any reason. I understand and acknowledge that the Released Parties have not arranged for and do not carry insurance of any kind for myself or my child(ren)/ward(s)’ benefit relative to my or their presence at or participation in activities at the LLSWS or LLBWS.

I acknowledge the LLSWS or LLBWS and other activities include physical challenges and potential risk including risks of minor, serious, and/or catastrophic injury. Inherent risks are risks that cannot be eliminated completely (although every effort is made to eliminate risk of injuries, accidents can happen regardless of the care and precautions taken by Released Parties). I acknowledge the inherent risks include, but are not limited to: (1) contact or collision with persons, including spectators and other participants, (2) contact or collision with natural or man-made fixed objects or obstacles such as bats, balls, the ground, pavement, or other materials or surfaces; (3) equipment-related and location-related hazards (e.g., pitching machines, batting cages, broken, defective or inadequate equipment, unexpected equipment failure); (4) weather-related hazards (e.g., extreme heat, extreme cold, humidity, rain, fog); (5) insufficient first aid and/or emergency measures, (6) judgment-related and/or behavior-related problems (e.g., erratic or inappropriate co-participant behavior, errors in judgment by personnel working or spectators at the event);(7) natural hazards (e.g. uneven terrain, lightning strikes, etc.) (8) allergic reactions from samples; and (9) exposure to communicable diseases. I acknowledge, assume and accept all risks and others not specifically named on behalf of myself and my minor child(ren)/ward(s).

I understand and acknowledge that any of these risks, and others not specifically named, may cause injury or injuries that may be categorized as minor, serious, or catastrophic. Minor injuries are

common and include, but are not limited to: scrapes, bruises, sprains, nausea, allergic reaction, and cuts. Serious injuries are less common but do sometimes occur. They include but are not limited to: property loss or damage, broken bones, torn ligaments, concussions, heat-related illness, exhaustion, and infection. Catastrophic injuries are rare; however, I am aware of the possibility. These injuries can include, but are not limited to, permanent disabilities, spinal injuries and paralysis, stroke, heart attack, and even death. With the exception of risks associated with conduct involving fraud, gross negligence, willful malfeasance, or reckless disregard, I acknowledge, assume and accept all risks that I or my minor child(re)/ward(s) may sustain including minor, serious, or catastrophic injury at the LLSWS or LLBWS or by participating in activities at the LLSWS or LLBWS.

I on behalf of myself and on behalf of my minor child(ren)/ward(s), understand and acknowledge that my and my minor child(ren)/ward(s)' presence at and participation in the LLSWS or LLBWS and other activities is wholly voluntary, and I am fully aware of the inherent hazards, dangers and risks involved, including death, disability, injury and/or property damage. I hereby certify that I, and my minor child(ren)/ward(s) am in good health and that I, and my minor child(ren)/ward(s) am physically and mentally capable of participating in activities at the LLSWS or LLBWS. I understand and acknowledge that this Release will extend even to those occurrences that arise out of my or my minor child(ren)/ward(s)' control. I understand that none of my minor child(ren)/ward(s) under the age limit as a child registrant will be contacted in a method that violates the COPPA guidelines.

I, on behalf of myself and on behalf of my minor child(ren)/ward(s), agree that the Released Parties shall have the right to film and take photographs/videos and capture and use audio including voice recording, at the LLSWS or LLBWS and I, on behalf of myself and on behalf of my minor child(ren)/ward(s), hereby grant LLB, Released Parties and other participating partners a royalty-free, worldwide, irrevocable license to use, exploit, adapt, modify, reproduce, distribute, publicly display and publicly perform, throughout the world in any and all forms whether now known or later developed, including, without limitation, all forms of media, the Released Parties' and third party social media pages and websites, my or my minor child(ren)/ward(s)' image, name, voice likeness, and other biographical information and statements attributed to me to of my child(ren)/ward(s) in any manner, including without limitation in any and all commercial exploits or ventures, promotional materials or announcements, publications, emails, media releases, or advertisements, electronic or otherwise (hereinafter collectively "Works"), in perpetuity, and waive any and all rights to the same, including without limitation, the right to review and approve same. Unless otherwise prohibited by applicable law, I acknowledge and agree that I, or my minor child(ren)/ward(s) will not receive any compensation whatsoever if my image, name, voice, likeness, any other biographical information, or statements attributed to me or my minor child(ren)/ward(s)' appear in any Works or from any proceeds of any utilized Works. I acknowledge and agree that any such image,

name, voice, likeness or resulting Works are solely the property of the Released Parties in perpetuity. In addition, I acknowledge and agree that the Released Parties may, without advance notice to me, supply such image, name, voice, likeness, and any other biographical information statements attributed to me, or my minor child(ren)/ward(s), or resulting Works to, or for any use and/or publication by, any third-party that any or all of the Released Parties determine in their/its sole discretion to be appropriate without my permission.

I, on behalf of myself and on behalf of my minor child(ren)/ward(s), hereby agree and acknowledge that by providing my verifiable parental consent to this Release, the Released Parties may collect, use, and disclose photos/videos, my personal information, and my minor child(ren)/ward(s)' personal information in accordance with this Release (including the Privacy Practices of the LLSWS and LLBWS and other activities) and the respective Released Parties' individual privacy policies.

I, on behalf of myself and on behalf of my minor child(ren)/ward(s), understand that a unique QR code will be created for each registered Little League World Series app (the "App") fan account that allows myself, and my child(ren)/ward(s) to interact and participate with on-site LLB and Sponsors at both the LLSWS and LLBWS. I, and on behalf of my minor child(ren)/ward(s), am responsible and agree to the proper usage, participation, and sharing of QR codes with my minor child(ren)/wards. I agree that I will not share my unique QR code with anyone except my minor child(ren)/wards. I acknowledge that the Released Parties are not liable for any QR codes that I screenshot or share electronically for another individual to use. I understand and acknowledge that LLB claims this Release will extend even to those occurrences that arise out of my or the minor child(ren)/ward(s)' control and that the Released Parties are not liable for any minor(s) who create, use, or engage with the App without parent's permission.

I understand that the information I provide through registration and this Release is used to create an interactive experience for the user and the user's minor child(ren)/ward(s). The Released Parties have the right to collect, use and disclose my name, image, likeness, and my personal information in accordance with this Release (including the Privacy Practices of the LLSWS or LLBWS and other activities) and the respective Released Parties individual privacy policies, for purposes including but not limited to: facilitating conversation with me and from time to time, to send me communications, to provide me information, offers and services.

Names, email addresses, and other information provided to the Released Parties from registration and App usage, and this Release either by the parent(s) or legal guardian(s) are incorporated into the Released Parties electronic database.

I, on behalf of myself and on behalf of my minor child(ren)/ward(s), hereby agree that this Release is intended to be as broad and inclusive as is permitted by the laws of the Commonwealth of Pennsylvania and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

I, on behalf of myself and on behalf of my minor child(ren)/ward(s) acknowledge that this Release is made in the Commonwealth of Pennsylvania and shall be construed and interpreted in accordance with the laws of the Commonwealth of Pennsylvania, applicable to contracts made and performed entirely therein without regard to conflicts of laws principles. I, on behalf of myself and

on behalf of my minor child(ren)/ward(s), agree and consent that jurisdiction and venue of all matters relating to this Release shall be vested exclusively in the federal, state, and local courts within Lycoming County, Pennsylvania.

I on behalf of myself and on behalf of my minor child(ren)/ward(s), acknowledge that this Release waives my, and my minor child(ren)/ward(s), important legal rights and that I have read and understand the contents of this Release and freely agree to its contents.

I understand and agree that by use of the App, I on behalf of myself and on behalf of my minor child(ren)/ward(s), am consenting to the collection, use, and disclosure of information as set forth herein, including, without limitation, communications regarding this Release will be sent by email to the address I have provided, and that I can elect not to have communications regarding this Release sent by email at any time or may request a copy of this Release by emailing Privacy@LittleLeague.org. The Released Parties may offer coupons, special discounts, contests, games, promotions, and other communications through the use of this data; or invite me to submit stories, photos, comments, or questions to certain areas of LLB's website.
