

# TERMS OF USE

# This Policy was last updated July 1, 2025

Welcome to Little League Baseball, Inc. ("Little League," "we," "us," or "our"). As the world's premier youth sports organization, we provide online and mobile services, content, tools, and platforms ("Little League Services") to support players, teams, leagues, and families across the globe.

By accessing or using any Little League Services, you agree to follow these Terms of Use and our Privacy Policy. If you do not agree, do not use our services.

## 1. USING OUR SERVICES

# 1.1 Eligibility

You must be at the legal capacity to use our Services. You must be 18 or older, if you are under the age of 18 you may only use this site under the supervision of a parent or legal guardian who agrees to be bound by these terms of use, provide accurate information, and follow all laws. Unauthorized or illegal use is prohibited and may lead to account termination. If you live outside the U.S., you must comply with applicable local laws and agree to be governed by U.S. law.

## 1.2 Account Registration

Some Services require an account. You must provide accurate, up-to-date information and keep it secure. You're responsible for your credentials and all activity under your account.

## 1.3 Acceptance

By using Little League Services, you confirm that you understand and accept these Terms. Continued use after any updates means you accept those changes.

## 1.4 Modifications

We may change these Terms at any time. We'll post the updated version, and your continued use of the Services means you accept the revised Terms.

## 2. DEFINITIONS

- **Users**: Anyone who uses Little League Services, including players, parents, coaches, volunteers, and administrators.
- Administrators: Individuals managing a league, team, or organization's use of the Services.



- **Organization Data**: Personal data related to league participants, provided by the organization.
- Little League Data: Information we collect directly from or about users during interaction with our Services.

## 3. SERVICES & CONTENT

#### 3.1 Access

You're granted a limited, personal, non-transferable license to use our Services as intended. We may change or discontinue any part of the Services at any time.

# 3.2 Ownership

All content (e.g., text, images, video, software) is owned by or licensed to Little League. You may not use it beyond what is allowed in these Terms.

## 3.3 User Content

By submitting any content, you grant Little League a license to use it for purposes related to our mission and operations.

## 4. STORE & eCOMMERCE

By using the Little League Official Store <a href="www.shoplittleleague.org">www.shoplittleleague.org</a> you agree to its Terms of Use ("LL Store Terms"), which govern your activity, and any merchandise orders placed there. If there is a conflict between this Agreement and the Store Terms, the Store Terms apply. Store Staff handle all merchandise fulfillment and shipping. - Attempt to gain unauthorized access to systems or accounts.
- Collect or misuse others' personal information.
- Upload viruses or malicious code.
- Use the Services for commercial purposes without permission.

#### 7. TERMINATION

We may suspend or terminate your access to the Services at any time for violations of these Terms or applicable laws. You may also cancel your account at any time.

#### 8. THIRD-PARTY LINKS & SERVICES

We may link to or integrate with third-party platforms. We're not responsible for those services, and your interactions with them are governed by their own terms.

## 9. DISCLAIMERS & LIMITATIONS

- Services are provided "as is" without warranties of any kind.
- We are not liable for indirect, incidental, or consequential damages arising from use of our Services.
- Some jurisdictions do not allow certain limitations, so these may not fully apply to you.

These Terms are governed by the laws of the United States and the Commonwealth of Pennsylvania. Any disputes will be resolved in the courts located in Lycoming County, Pennsylvania.

- **No Waiver**: Failure to enforce a provision is not a waiver of that right.
- Severability: If any part is invalid, the rest remains enforceable.
