- Encourage leagues to charter/insure as soon as they are able, understanding the 2020 policies expired 1/1/2021
- Make sure to update league officers in Data Center
- Leagues should charter estimated number of teams they may have, knowing they can adjust accordingly; does not affect their Liability quote for 2021
- 2020 ASAP awards and District Incentives were credited to league/district accounts in Sept 2020

#### 2020/2021 Little League Season Insurance FAQ - Little League

## **CHARTERING CREDIT FROM 2020:**

- Check for credits to your League Account in the Data Center. If your league has a credit, which will be shown in the "outstanding balance" box on the Data Center, that credit will be applied to your 2021 chartering and insurance enrollment.
- Little League International credited all chartered programs with the \$10 per team affiliation fees paid for their chartered teams in 2020, regardless of whether or not your league was able to hold a season last year. We hope this will help ease the financial burden of all leagues entering the 2021 season.
- Leagues who submitted an approved ASAP plan in 2020 also have received their program award based on 15% of their Accident Insurance premium credited through the Data Center.

# **COVID Boundary Expansion**

- District Administrator confirms that a local league will not be active in 2021. This is intended to be for the 2021 season, only
- Contiguous league agrees to expand boundaries to cover the territory
- District Administrator forwards request and district recommendation
  to Regional Office
- Boundary map is adjusted in the Little League mapping system
- Regional Office sends approval to local league

### **Out of Boundary Players-Data Center** League

Leagues will be permitted to accept players who otherwise would not be eligible to participate in their league, if the player's home league has concluded or suspended all team activity for the 2021 season by adhering to the following process:

- League must submit a list of out of boundary players through the approved process on the Little League Data Center coming in early 2021:
  - 1. Player information (Player's name, league age, Parent/Legal Guardian contact *information*)
  - 2. Player's Home league
- District Administrator to review list of out of boundary players
- Regional Office will review and provide final approval with supporting waiver documentation from home league



# Background Checks: know your state

## TAX EXEMPT STATUS REMINDER:

- Each local league and district is responsible for submitting a federal tax return to the Internal Revenue Service (IRS). Any non-profit organization that does not file the proper 990 Form with the IRS for three consecutive years automatically loses its federal tax exemption resulting in the organization's income becoming taxable and contributors being unable to report their contributions as tax deductions. This year's filing deadline is February 16, 2021.

### **DA YEAR-END REPORTS:**
